### Ohio Board of Regents Update

Rebecca Watts described the work of the Complete College Ohio Task Force Report & Recommendations, some highlights of which follow:

- adopt a consistent statewide college readiness definition
- establish PK-16 partnerships
- require every IHE to submit a campus completion plan
- recalculate funding formulas based on completion, not on admissions
- PARCC assessment in high school for college and career readiness
- Offer financial literacy and planning for families FASFA

The Reading Endorsement will be offered at the graduate level only. Programs must be 15-21 hours. Undergraduate students currently enrolled in programs must be finished by June, 2014.

## Ohio Department of Education

John Soloninka reported for ODE. PRAXIS I will continue to be used until Sept 1, 2014. The updated licensure chart released in July will reflect the new requirements. Check the ODE website for updates on new OAE Pearson tests.

Matt Lutz, Director of the Office for Educator Equity and Talent presented information about the Ohio Teacher Evaluation System and the Ohio Principal Evaluation system.
