3. **Education Department, Harvard To Tackle Rural School Challenges:** Ohio schools will be a focal point of a grant-funded project at Harvard University aimed at improving educational outcomes for students in rural areas. With a \$10 million grant from the federal Institute of Education Sciences, Harvard will establish the National Center for Rural Education Research Networks, the Department of Education announced Thursday. The center over the five-year life of the grant will work with 60 rural school districts in New York and Ohio to research and implement programs aimed at reducing absenteeism and boosting college readiness and enrollment.
4. **House Adopts Modified Rules:** Democrats continued to be encouraged by House **Speaker Larry Householder's** approach to the 133rd General Assembly after the chamber unanimously adopted several rule changes Wednesday. The rule changes in part: increase minority party representation on committees to 40%, eliminate the requirement floor amendments be submitted to the clerk at least two hours before session and make it more difficult to block amendments by previously amending the same bill section. The rules also finalize the roster of standing committees, decreasing the overall number of committees to 20. They also establish three subcommittees – on K-12 education funding, energy generation, and criminal sentencing – to be co-chaired by members of both parties.
